The MERS Retirement Board consists of nine (9) members. Six (6) members are nominated and voted upon by MERS members, and three (3) are appointed by the Retirement Board.

Of the three appointed members, two are considered Public Members. Public Members have knowledge or experience in retirement systems, administration of retirement systems, or investment management or advisory services.

One is considered a **Retiree Member** and is a retiree of the MERS system. "Retiree" is defined as an individual who is receiving a retirement allowance as a result of former membership in the Defined Benefit Plan or Hybrid Plan and/or is eligible to receive a tax penalty-free distribution under the Internal Revenue Code as a result of former membership in the MERS Defined Contribution Plan or Hybrid Plan.

This year, one Retiree Member position will be appointed at the Board Meeting in December. If you meet the requirements listed above for a Retiree Member and would like to be considered for appointment to the MERS Retirement Board, please complete the form below (both front and back pages). This form, along with your **resume must be received by MERS by Friday, September 17, 2021.**
